**Program Overview:** The SIG SAUER Training Package is intended for Ranges or Organizations providing one or more of the following firearms training opportunities: Handgun 101 Training, Concealed Carry Training, or New Shooter/Introduction to Firearms Training. The Program is directed toward Ranges and Organizations providing these training opportunities in a group setting, and with a focus on promoting proper pistol use, handling, and firearms safety practices. All P320, P365, P322 pistols, and pistol mounted optics on the current Commercial Dealer price list at time of Program launch are available to be purchased under the Program. Initial minimum order is ten (10) of the same model in either the P320, P365, or P322 Polymer Pistol product lines. Dealer can purchase Electro-Optic equipped SKUs in these product lines, or a qualifying Polymer Pistol product plus a SIG SAUER Electro-Optic product purchased separately. Dealer may order a maximum of twenty (20) pistols with the understanding they must order a minimum of ten (10) pistols of any given model.

**Dealer shall furnish the following required documents for approval of participation:**

- Signed 2026 SIG SAUER Training Package Agreement
- Copy of a current Federal Firearms License with an original signature in black/blue ink
- Photographs of the facility, both inside and outside
- Copies of State Sales Tax and Resale Certificates (as applicable)

**To qualify for Program participation, Dealer’s facility must meet the following guidelines:**

- Have multiple shooting lanes or stations
- Meet all Federal/State guidelines, including OSHA requirements
- Be open to the public by membership and/or walk-in traffic
- Be open regularly during established business hours
- Have employees present during regular business hours

**2026 TRAINING PACKAGE AGREEMENT TERMS AND CONDITIONS**

1. Program Term: Products are available for order between January 1, 2026, through December 1, 2026. The terms herein shall apply through the duration of Dealer's use of the products ordered under this Program, which shall not exceed twelve months from the date of final receipt of products ordered hereunder.
2. Order Requirements: The SIG SAUER Training Package Program is intended for Ranges or Organizations providing one or more of the following firearms training opportunities: Handgun 101 Training, Concealed Carry Training, or New Shooter/Introduction to Firearms Training. The Program is directed toward Ranges and Organizations that provide these training opportunities in a group setting, and with a focus on promoting proper pistol use, handling, and firearms safety practices. All P320, P365, and P322 pistols on the current Commercial Dealer price list at time of Program launch are available to be purchased under the Program. Initial minimum order is ten (10) of the same model in either the P320, P365, or P322 Polymer Pistol product lines. Dealer can purchase optic-equipped SKUs in these product lines, or a qualifying Polymer Pistol product plus a SIG SAUER Electro-Optic product purchased separately. Dealer may order a maximum of twenty (20) pistols, providing they order a minimum of ten (10) pistols for any given model. All orders must be received by December 1, 2026.
3. Pricing: Orders under the program will receive a 40% discount off the current Commercial Dealer price list at time of order.
4. Payment Terms: Not applicable.
5. Fill Orders: Fill orders (orders after initial order) are not available, except for orders for NPI products.
6. Backorders: All backorders will be shipped at the discounted Commercial Dealer price current at time of order placement.
7. Freight: Per Distributor requirements.
8. Excluded and Restricted Models: All SIG SAUER Firearms listed on the Commercial Dealer price list are eligible for purchase under the Program. SIG SAUER reserves the right to exclude limited run models. Used SIG SAUER Firearms and LE models are prohibited for purchase under the Program.
9. Proof of License: Dealer is required to provide a copy of its valid FFL signed in black/blue ink, along with a copy of state and local resale certificates and licenses, where applicable.
10. Credit applications: Not applicable.
11. Optics and Suppressors: Only SIG SAUER Electro-Optics and Suppressors may be used on SIG SAUER Firearms purchased under this Program.
12. Program Purchases/Range Inventory: All products purchased under this Program must be maintained in good condition in Dealer's range rental inventory for one year (12 months) after receipt of product, or until such item has been discontinued from the Commercial Dealer price list, whichever is sooner. If any product purchased under this Program is sold or otherwise disposed of by Dealer prior to the end of the Program, Dealer's participation in the Program will be terminated, and Dealer will be billed for the difference of the discounted price and the list price for all products purchased under the Program.
13. Sale of Program Firearms: Upon completion of 12-month term of use, or discontinuation of product from the Commercial Dealer price list, Dealer may, at their expense, ship all firearms to SIG SAUER for the Full-Service Package (FSP). As part of the FSP, SIG SAUER will conduct thorough cleaning and inspect critical components prone to wear. FSP package will cover components under warranty for manufacturer defect, but dealer will be required to pay for all wear-and-tear component items. SIG SAUER shall return the firearms to the dealer for resale as a used firearm. FSP/used firearm sales are not eligible for SIG Rewards.
14. Product Maintenance and Repair: Dealer agrees to provide basic maintenance to all firearms purchased under the Program, including lubrication, cleaning, and replacement of pistol recoil springs. SIG SAUER will repair or replace firearms (at its discretion) which require additional service attributable to normal use, providing the Dealer maintains an accurate round count and service record for the firearm. Failure to maintain proper records and supply them to SIG SAUER upon request will result in termination of this repair service for Dealer.
15. Identification of Program Participation/POS Display: Dealer shall be authorized to represent itself as an Official SIG SAUER Range Program participant for the term of the Program, or until Dealer's participation is terminated hereunder. Dealer shall display point-of-sale materials sold or provided by SIG SAUER.
16. Ammunition: Dealer agrees to use only new, commercial factory ammunition manufactured to NATO or SAAMI specifications in any firearms purchased under the Program. Dealer agrees that it will not use reloaded or re-manufactured ammunition in any SIG SAUER Firearm. A violation of these conditions will result in termination of Dealer's participation in the Program and may void the firearm's warranty.
17. Product Literature: Dealer (and all employees thereof) agrees to read the entire instruction manual for each model firearm purchased under the Program before renting or using these firearms.
18. Indemnification: Dealer agrees to indemnify, defend, and hold harmless SIG SAUER and its employees, agents, and assigns from and against any and all claims, actions, suits, liabilities, damages, fees, or fines arising out of or related to the misuse or abuse of any SIG SAUER product purchased under the Program, or the negligence or willful misconduct of Dealer or its employees.

Dealer/Range hereby agrees to the terms and conditions applicable to the SIG SAUER Training Package (the "Program") contained herein, and agrees that no contrary, additional, or different terms are applicable to the Program or Dealer's participation therein.
